Please find the following content in our current abstract section to answer this question: This study contributes to the novelty of measuring the impact of zakat distribution on productive means using quantitative and qualitative approaches with a particular evidence from a post-disaster area.
- Please add the background of the study in abstract. Please find the following content in our current abstract section to understand the brief background of our study: This study investigates BAZNAS Microfinance Desa (BMD) Sigi program's impacts on the material and spiritual well-being of the Mustahiq (zakat beneficiaries).

Thank you for raising this issue and we are happy to inform you about the changes made for the clarity of research method. Please be informed that previous revision has covered the revision of how the mix-mode method is performed in our study. That is, the quantitative CIBEST- was first executed to gain quantitative evidence of zakat impacts. In addition, the qualitative observation was further used to understand what is behind the quantitative results as gained by using CIBEST model. In the research method section, you'll find this that better explains how quantitative and qualitative works are executed; To measure the impact of productive zakat distribution by BMD Sigi, this study used a mixed method approach that combined qualitative and quantitative approaches (Creswell, 2013). This study first employed CIBEST analysis to generate quantitative evidence of such productive zakat impacts, followed by qualitative observation to understand the facts behind the quantitative results.
